Introduction :- To establish a new school on the basis of Non Granted self financial arranged application for permission to be given is under consideration of Amal Jyoti Charitable Society Trust Lonand, Tal- Khandala, Dist- Satara organized by Mount Carmel Convent School, Lonand, Tal- Khandala, Dist- Satara.

Government Decision : 2.1) Maharashtra Non Granted (Self Finance School Establishment and regulation) rule, 2012 (2013) (01) under Amal Jyoti Charitable Society Trust Lonand, Tal- Khandala, Dist- Satara operated Mount Carmel Convent School, Lonand, Tal- Khandala, Dist- Satara New Primary to Higher Secondary School (1st Standard to 12th Standard) English medium, all branches (C.B.S.E.) for the year 2018-2019 academic year, permission is given by the government, Subject to terms and conditions as follows.

2.2 Terms and Condition :-

- 1) Institute have to submit extended three years deposit receipt, 3 years proceeding audit balance sheet to Divisional Deputy of Education, Kolhapur within the period of three months. Foiling of which to comply sanction given is automatically presold to be cancelled
 - 2) The school must comply permission of right to free and compulsory Education Act 2009 and all the rules and regulations made under it.
 - 3) The following letter for permission to start the school for Academic year 2018-2019 is given under code 2009 with complying the condition.
- (A) If the management has fulfilled all the requirement as per prescribed the rule of the governments from the starting of academic year, within one month they have to apply for first sanction to the educational officer of the concerning district.

(B) For the academic year 2018-2019 management is given sanctioned to start the school subject to condition that as per government rules If all essential things are not available, they have given time of 18 month from the date of government order from starting school otherwise granted permission automatically stand cancelled.

(C) As per policy the policy prescribed in GR dated 20june 2012 to get the NOC for CBSE affiliation the prior sanction of recognition is essential from District Education Officer as per government order para.10. There after the said recognition from Primary District Education Officer/Secondary District Education Officer, Satara along with said recognition letter, there after the concerned institute may apply to government for NOC to apply for CBSE. After scrutinizing the application and satisfying that the concerned school complies all the rules, conditions, then the government will issue NOC for affiliation with concern board.

4) The new school which has been given permission to be follows 1) The order and procedure issued by government from time to time. 2) It will be mandatory to comply with all the provision and procedures as per Maharashtra Government Non Granted (Self Financial Arranged) establishment and regulation Act 2012-2013.

5) It is for the competent concerning officer, to give permission after satisfying that provision of the code 2009 complied and thereafter he has to follow the first sanction procedure.

6) Institute should not change the place, medium in future other that at the time of permission it applied. If institute started to school at the place other than sanctioning place., Government sanction automatically stands cancelled.

7) U-DISE Data :- District wise regarding new school/ upgraded sheets allowed by this rules U- DISE (Unified District Information System for Education), while filling the information in U-Dias, it will be responsibility on the concerned organization to get the number by registering in a separate category as a school sanctioned on Non-Granted (Self help basis). In order to take further action in this regard, The State Project Director, Maharashtra Primary Education Council, Mumbai has been declared as the nodal officer- Similarly, for the information of all concerned, the institute will be required to put up a public notice board at the entrance outside the school standing that the school has been sanctioned on self-financed (Non-Granted) basis or the school has been upgraded.



8) Recruitment of teachers and non-teaching staff in permitted self-financed school should be done as per prevailing rules and policies of government.

(3) It is the responsibility of the Concerning Divisional Deputy Director of Education to inform the concerned institute within 15 days as per the order in the names of Governor of Maharashtra.
